Your supporting documents

Before you begin your application please ensure you have the following documents to submit:

- Proof of ID (birth certificate, passport or driving licence – .txt, .doc, .xlsx. BMP, GIF, JPEG, TIFF or PDF)
- A passport-sized photo (ideally with a white background - GIF, JPG or JPEG only)
- ACCA Accelerate Authorisation letter from your course tutor/head of department (Contact our Education team if you are unsure)
- Undergraduate degree transcript if you are currently doing a postgraduate degree program (PDF)
- If any of the documents are not in English, please provide an official translation of the document in English

Upload your academic transcript under 'Proof of qualifications' if you hold other qualifications previously.

When asked for **'Proof of minimum entry qualifications'** please upload Accelerate letter from your course tutor/ head of department.

- Step 8 Once all the relevant photo and supporting documents are uploaded, you will be able to view a summary of your application this is important to ensure all your details are correct. You can amend any details by using the left hand side menu to return to a particular section. Once all the details are checked, tick the box to confirm that you have read and accepted ACCA's terms and conditions at the bottom of the page.
- Step 9 You will be directed to the payment page where the Initial Registration fee can be made. This fee is associated to your Accelerate code. Please refer to your university Accelerate agreement for details of the ACCA fees that you will be liable to pay in future.
