- 2 Entry is open to all Pakistan private and public sector entities (including NGOs and SMEs).
- 3 There are no restrictions on the medium used to transmit the performance data (eg: annual reports and accounts, stand-alone reports, videos, CD-ROMs, websites, etc).
- 4 Organisations submitting entries should supply website address of the documents or items which they wish to be considered by the judging panel for the Awards. Only internet based entries will be accepted.
- 5 Organisations will be notified as to whether or not they are to receive an award following the meeting of the judging panel (February 2014).
- 6 The Ceremony for the ACCA-WWF Pakistan Environmental Reporting Awards 2013 is scheduled to take place in June 2014.
- 7 ACCA is unable to enter into correspondence relating to the merits of individual submissions. The decision of each panel of judges is made in good faith and is final. The views of the panel of judges are expressed in an annual report published after the ceremony.
