Yet by focusing on the wider impact that care can have, health and social care services can start to see the total contribution they make and the value they create to the lives of their patients and indeed society at large. This is important because, as health and social care services are being increasingly challenged with maintaining or improving outcomes wthin the same or reduced resources, communicating how well they are able to achieve this will be critical to public accountability.
