The ACCA Job Hunting Competition is a nation-wide competition held in Beijing, Shanghai, Chengdu, Guangzhou and Hong Kong. STAGES OF THE COMPETITION

Stage 1 – Submission of Online Application

Eligible students are required to complete and submit the online application via <http://cn.accaglobal.com/jhc2012> before 4 March 2012 (Sunday) midnight.

Stage 2 – Aptitude Test

Sixty candidates will be shortlisted from the entries to participate in the Aptitude Test. The test is a numerical reasoning and verbal reasoning test with all multiple choice questions. Participants will be asked to evaluate the logic of given statements and interpret data from statistical tables.

Stage 3 – Semi-final

In the Semi-final, the 24 semi-finalists will be divided into groups to attend group interview session with experienced recruitment consultants from Michael Page International where participants will have the opportunity to get valuable face-to-face feedback from the judges.

Stage 4 – Job Hunting Workshop & Hong Kong Final Competition
