## **Disciplinary Committee ordered Exclusion from Membership\***

On 27 August 2019, the Disciplinary Committee of ACCA (the Association of Chartered Certified Accountants) found proved the following allegations against Mr Mohammed Mohsin, of Gants Hill, Essex, United Kingdom:

### Allegation 1

- (a) On 11 December 2017, Mr Mohammed Mohsin was convicted at Blackfriars Crown Court of supplying false or misleading information to the Charities Commission, which is discreditable to the Association or the accountancy profession;
- (b) By reason of his conduct at 1(a) above, Mr Mohammed Mohsin is liable to disciplinary action pursuant to by-law 8(a)(ix).

The Disciplinary Committee ordered that Mr Mohsin be excluded from ACCA Membership and to pay costs to ACCA in the sum of £5,000.

Please note that this may be the subject of an appeal.

ACCA's regulations require ACCA to publish the Committee's findings and orders by way of a news release, as soon as practicable.

*\* An order made by the Disciplinary Committee shall take effect from the date of expiry of the Appeal Period referred to in the Appeal Regulations unless the Committee directs that the order should have immediate effect*
