## Disciplinary Committee ordered Removal from Student Register \*

On 4 March 2019, the Disciplinary Committee of ACCA (the Association of Chartered Certified Accountants) found proved the following allegations against Miss Jia Yi Han, of Beijing, China:

### Allegation 1

- a) During an F7 Financial Reporting examination on 05 June 2018, Miss HAN Jia Yi:
  - i. was in possession of unauthorised materials, which she had at her desk, contrary to Examination Regulations 4, and/or 5.
  - ii. used or intended to use any or all of the items set out at 1(a)(i) above to gain an unfair advantage, contrary to Examination Regulation 7;
  
- b) Miss HAN's conduct in respect of 1(a) above was:
  - i. Dishonest, in that Miss HAN used or intended to use any or all of the unauthorised materials which she had at her desk to gain an unfair advantage; and
  - ii. Contrary to the Fundamental Principle of Integrity (as applicable in 2018);

c) By reason of her conduct, Miss HAN is:

- i. Guilty of misconduct pursuant to bye-law 8(a)(i), in respect of any or all of the matters set out at (a) and (b) above

The Disciplinary Committee ordered that Miss Jia Yi Han be removed from the student register and pay costs to ACCA in the sum of £1500.00

Please note that this may be the subject of an appeal.

ACCA's regulations require ACCA to publish the Committee's findings and orders by way of a news release, as soon as practicable.

*\* An order made by the Disciplinary Committee shall take effect from the date of expiry of the Appeal Period referred to in the Appeal Regulations unless the Committee directs that the order should have immediate effect*
