## Disciplinary Committee ordered Removal from Student Register \*

On 08 May 2019, the Disciplinary Committee of ACCA (the Association of Chartered Certified Accountants) found proved the following allegations against Ms Mansura Mammadova, of Azerbaijan:

### Allegation 1

- a) During a DipIFR examination on 8 June 2018, Ms Mansura Mammadova was in possession of unauthorised materials which she had at her desk contrary to Examination Regulations 4 and/ or 5.
- b) Ms Mansura Mammadova intended to use any or all of the materials set out at 1(a) above to gain an unfair advantage, contrary to Examination Regulation 7 (a).
- c) Ms Mansura Mammadova conduct in respect of 1(b) above was:
  - i. Dishonest, in that Ms Mansura Mammadova intended to use any or all of the unauthorised materials which she had at her desk to gain an unfair advantage;
  - ii. Contrary to the Fundamental Principal of Integrity.
- d) By reason of her conduct, Ms Mansura Mammadova is:
  - i. Guilty of misconduct pursuant to bye-law 8(a)(i), in respect of any or all of the matters set out at 1(a) to 1(c) above.
