Disciplinary Committee ordered Exclusion from Membership*

On 13 November 2019, the Disciplinary Committee of ACCA (the Association of Chartered Certified Accountants) found proved the following allegations against Miss Deepshika Esha Gungadin, of Ilford, Redbridge, United Kingdom:

Allegation 1

- (a) Between 1 January 2018 and 30 November 2018 Miss Deepshika Gungadin, an ACCA member, misappropriated amounts totalling £29,736.69 belonging to Firm A;
- (b) Miss Deepshika Gungadin's conduct was
 - (i) Dishonest in that Miss Deepshika Gungadin knew that she was acting wrongfully and without lawful excuse in misappropriating £29,736.69 belonging to Firm A.
- (c) By reason of her conduct, Miss Deepshika Gungadin is guilty of misconduct in respect of any or all of the matters set out above at 1(a) or 1(b) pursuant to bye-law 8(a)(i).

The Disciplinary Committee ordered that Miss Gungadin be excluded from membership, and to pay costs to ACCA in the sum of £2,400.

Please note that this may be the subject of an appeal.

ACCA's regulations require ACCA to publish the Committee's findings and orders by way of a news release, as soon as practicable.

* An order made by the Disciplinary Committee shall take effect from the date of expiry of the Appeal Period referred to in the Appeal Regulations unless the Committee directs that the order should have immediate effect
