Disciplinary Committee ordered Exclusion from Membership*

On 31 October 2019, the Disciplinary Committee of ACCA (the Association of Chartered Certified Accountants) found proved the following allegations against Mr Hassan Ali Hassan, of Nairobi, Kenya:

Allegation

- (a) Mr Hassan Ali Hassan attempted to deceive the exam co-ordinator by giving false or misleading information to him as to his identity before and in connection with an exam on 11 August 2018 at Strathmore University CBE Centre.
- (b) Mr Hassan Ali Hassan's conduct above was:
 - (i) Dishonest, in that he attempted to deceive the exam co-ordinator by impersonating Person A the exam entrant;
- (c) By reason of his conduct, Mr Hassan Ali Hassan is guilty of misconduct pursuant to bye-law 8(a)(i) in respect of any or all of the matters set out at (a) and (b) above

The Disciplinary Committee ordered that Mr Hassan Ali Hassan be excluded from student membership and to pay costs to ACCA in the sum of £1,500.

Please note that this may be the subject of an appeal.

ACCA's regulations require ACCA to publish the Committee's findings and orders by way of a news release, as soon as practicable.

* An order made by the Disciplinary Committee shall take effect from the date of expiry of the Appeal Period referred to in the Appeal Regulations unless the Committee directs that the order should have immediate effect
