Disciplinary Committee ordered Removal from Student Register*

On 24 September 2019, the Disciplinary Committee of ACCA (the Association of Chartered Certified Accountants) found proved the following allegations against Mr Abdul Khabir, of Kabul, Afghanistan:

Allegation 1

- a) On 24 October 2018, Mr Abdul Khabir, an ACCA student, caused or permitted one or more of the documents set out in Schedule A to be submitted to The Association of Chartered Certified Accountants (“ACCA”), which purported to have been issued by the University of Greenwich when, in fact, they had not;
- b) Mr Abdul Khabir’s conduct in respect of 1(a) was:
 - i. Dishonest, in that Mr Khabir knew or did not care that one or more of the document/documents set out in Schedule A were false
- c) By reason of his conduct in respect of any or all of the matters set out at 1(a) and/or 1(b) above, Mr Khabir is guilty of misconduct pursuant to bye-law 8(a)(i).

The Disciplinary Committee ordered that Mr Abdul Khabir be removed from ACCA’s student register and to pay costs to ACCA in the sum of £5,100.

Please note that this may be the subject of an appeal.

ACCA’s regulations require ACCA to publish the Committee’s findings and orders by way of a news release, as soon as practicable.
