Disciplinary Committee ordered Removal from Student register*

On 18 August 2020, the Disciplinary Committee of ACCA (the Association of Chartered Certified Accountants) found proved the following allegations against Miss Xinyue Wu, of Hangzhou, Zhejiang, SAR China:

Allegation 1

- (a) During a Financial Management examination on 07 June 2019, Miss Xinyue Wu was in possession of unauthorised materials which she had at her desk, contrary to Examination Regulations 4 and/or 5.
- (b) Miss Xinyue Wu intended to use the unauthorised materials above to gain an unfair advantage, pursuant to Examination Regulation 7(a);
- (c) Miss Xinyue Wu's conduct in respect of 1(b) above was:
 - i) Dishonest, in that she intended to use the unauthorised materials which she had in her possession while the exam was in progress to gain an unfair advantage.
- (d) By reason of her conduct, Miss Xinyue Wu is:
 - i) Guilty of misconduct pursuant to bye-law 8(a)(i), in respect of any or all of the matters set out at 1(a) to 1(c) above;
