## **Disciplinary Committee ordered Removal from Student Register\***

On 16 June 2020 the Disciplinary Committee of ACCA (the Association of Chartered Certified Accountants) found proved the following allegations against Mr Md Miraz Hossan, of Dhaka, Bangladesh:

### Allegation 1

On 25 November 2019, Md Miraz Hossan, an ACCA student, caused or permitted one or more of the documents set out in Schedule A to be submitted to The Association of Chartered Certified Accountants ("ACCA"), which purported to have been issued by Anglia Ruskin University when, in fact, they had not;

### Allegation 2

Md Miraz Hossan's conduct in respect of 1 was:

- (a) Dishonest, in that he knew the documents he submitted to ACCA described in schedule A are false and he submitted them to gain exemptions he was not entitled to;

### Allegation 3

By reason of his conduct in respect of any or all of the matters set out at 1 and/or 2 above, Md Miraz Hossan is guilty of misconduct pursuant to bye-law 8(a)(i)

The Disciplinary Committee ordered that Mr Miraz Hossan be removed from Student Register and to pay costs to ACCA in the sum of £5,000.
