Disciplinary Committee ordered Removal from the Student Register*

On 28 May 2020, the Disciplinary Committee of ACCA (the Association of Chartered Certified Accountants) found proved the following allegations against a student, Miss Miao Tian, of Inner Mongolia, China:

Allegation 1

- (a) During an SCBE Audit and Assurance examination on 3 June 2019, Miss Miao Tian was in possession of unauthorised materials in the form of notes under her key board, contrary to Examination Regulations 4 and/or 5.
- (b) Miss Miao Tian intended to use any or all of the items set out at (a) above to gain an unfair advantage, contrary to Examination Regulation 7a;
- (c) Miss Miao Tian's conduct in respect of (b) above was:
 - (i) Dishonest, in that Miss Miao Tian intended to use any or all of the unauthorised materials which she had at her exam desk to gain an unfair advantage; or in the alternative
 - (i) Contrary to the Fundamental Principle of Integrity (as applicable in 2019);
- (d) By reason of his conduct, Mis Miao Tian is:
 - (i) Guilty of misconduct pursuant to bye-law 8(a)(i), in respect of any or all of the matters set out at (a)-(c) above; or
 - (ii) Liable to disciplinary action pursuant to bye-law 8(a)(iii), in respect of (a-c) above.

The Disciplinary Committee ordered that Miss Tian be removed from the student register, and to pay costs to ACCA in the sum of £5,500.00.
