Disciplinary Committee ordered exclusion from membership with immediate effect*

On 09 Novemebr 2020, the Disciplinary Committee of ACCA (the Association of Chartered Certified Accountants) found proved the following allegations against Mr David James Pape, of Glossop, Derbyshire, United Kingdom:

Allegations

1. On 23 July 2019, David James Pape FCCA was convicted of the following offences at Manchester (Crown Square) Crown Court, which are discreditable to the Association and the accountancy profession:
 - i. Furnishing false information relating to accounts;
 - ii. Conceal/disguise/convert/transfer/remove criminal property.
2. By reason of his conduct at 1 above, David James Pape FCCA is liable to disciplinary action pursuant to bye-law 8(a)(ix).
3. On 12 September 2019, David James Pape FCCA was disqualified from holding the position of a director for a period of ten years.
4. By reason of his conduct at 3 above, David James Pape FCCA is guilty of misconduct pursuant to bye-law 8(a)(i).

The Disciplinary Committee ordered that Mr Pape be excluded from membership and to pay costs to ACCA in the sum of £4,400.
