### Disciplinary Committee ordered Removal from Student Register\*

On the 10 November 2020 the Disciplinary Committee of ACCA (the Association of Chartered Certified Accountants) found proved the following allegations against Miss Kangxin Liang, Sichuan, China.

## **Allegations**

# Allegation 2

- 2.1 Contrary to Paragraph 3(1) of the Complaints and Disciplinary Regulations2014, Miss Liang has failed to co-operate fully with the investigation of a complaint in that:
- 2.2 Miss Liang failed to respond at all to ACCA's correspondence dated:
  - 2.2.1 06 November 2019;
  - 2.2.2 28 November 2019; and
  - 2.2.3 13 December 2019;
- 2.3 By reason of her conduct in respect of any or all of the matters set out at 2.1 and 2.2 above, Miss Liang is:
  - 2.3.1 Guilty of misconduct, pursuant to bye-law 8(a)(i).
