Disciplinary Committee ordered that student be removed from the register *


On 28 September 2021, the Disciplinary Committee of ACCA (the Association of Chartered Certified Accountants) found proved the following allegations against Mr Yifan Yuan of Hangzhou, China:

Allegations

- a. During a Financial Management (FM) examination on 10 July 2020, Mr Yifan Yuan :
 - ii. Was in possession of unauthorised materials in the form of notes stored or otherwise accessible on the mobile phone referred to in Allegation 1(a)(i) above, contrary to Examination Regulation 4.
- b. Mr Yifan Yuan intended to use the mobile phone and materials stored or otherwise accessible on that mobile phone as referred to above to gain an unfair advantage.
- c. Mr Yifan Yuan's conduct in respect of Allegation 1(a) and/or Allegation 1(b) above was:
 - i. Dishonest, in that Mr Yifan Yuan intended to use the mobile phone and notes to gain an unfair advantage in the exam.
- d. By reason of his conduct, Mr Yifan Yuan is:
 - i. Guilty of misconduct pursuant to bye-law 8(a)(i) in respect of any or all of the matters set out at Allegations 1(a) to 1(c) above.
