Disciplinary Committee ordered Removal From Student Register*

On 02 December 2022, the Disciplinary Committee of ACCA (the Association of Chartered Certified Accountants) found proved the following allegations against Miss Stacey Moto of Kampala, Uganda:

Allegations

1. Miss Stacey Moto (“Miss Moto”), a student of the Association of Chartered Certified Accountants (“ACCA”):
 - a. On 28 January 2021 and/or on 01 February 2021, submitted to ACCA, a false provisional exam result document dated 17 May 2019 purporting to be from the Academy For Career Enhancement (“the Document”).
2. The conduct described at Allegation 1(a) was:
 - a. Dishonest, in that Miss Moto knew the Document was not genuine and/or intended to use the Document to mislead the ACCA
3. Contrary to Regulation 3(1) of the Complaints and Disciplinary Regulations 2014 (as amended and in force at the time), Miss Moto failed to co-operate with the investigation of a complaint in that she failed to responds to any or all of ACCA’s correspondence dated:
 - a. 23 August 2021;
 - b. 14 September 2021;

c. 15 October 2021.

4. By reason of the conduct described in any or all of the matters, Miss Moto is:

a. Guilty of misconduct pursuant to bye-law 8(a)(i)

The Disciplinary Committee ordered that Miss Stacey Moto be removed from student register and to pay costs to ACCA in the sum of £5,868.

Please note that this may be the subject of an appeal.

ACCA's regulations require ACCA to publish the Committee's findings and orders by way of a news release, as soon as practicable.

** An order made by the Disciplinary Committee shall take effect from the date of expiry of the Appeal Period referred to in the Appeal Regulations unless the Committee directs that the order should have immediate effect*
