Member severely reprimanded*

On 06 December 2022 the Consent Orders Chair of the Association of Chartered Certified Accountants (ACCA) found proved the following allegations against a member, Mr David Edward Greening from Norwich, United Kingdom:

Allegation 1

From 26 June 2017 to 22 July 2022, Mr David Edward Greening failed on behalf of the firm to comply with the requirements of the Money Laundering, Terrorist Financing and Transfer of Funds (Information on the Payer) Regulations 2017 (the regulations), namely:

- 1.1 Regulation 18 (Risk assessment by relevant persons)
- 1.2 Regulation 19 (Policies, controls and procedures)
- 1.3 Regulation 24 (Training)
- 1.4 Regulation 33(6) Obligation to apply enhanced customer due diligence.

Allegation 2

From 26 June 2017 to 14 July 2022, Mr David Edward Greening failed to comply with Section B2 of ACCA's Code of Ethics and Conduct (Anti-Money Laundering) (as applicable from 2017 to 2022).

Allegation 3

By reason of his conduct in respect of the all the matters set out at allegations 1 to 2, is guilty of misconduct pursuant to bye-law 8(a)(i).

The Consent Orders Chair ordered that Mr Greening be severely reprimanded, pay costs to ACCA in the sum £750.00, and a fine in the sum of £5000.00.
