Disciplinary Committee ordered Member excluded*

On 16 March 2022, the Disciplinary Committee of ACCA (the Association of Chartered Certified Accountants) found proved the following allegations against Mr Usman Ghani, from London UK:

Allegations

Mr Usman Ghani, at all material times an ACCA affiliate

1. Submitted or caused to be submitted to ACCA on or about 28 May 2017 an ACCA Practical Experience training record which purported to confirm:
 - a) His Practical Experience Supervisor in respect of his practical experience training in the period 25 May 2016 to 28 May 2017 was Mr A when Mr A did not and/or could not supervise his practical experience training in accordance with ACCA's requirements as set out and published in ACCA's PER Guidance (the Guidance);
 - b) He had achieved any or all the performance objectives claimed in his training record.
2. Mr Ghani's conduct in respect of the matters described in allegation 1 above was:
 - a) In respect of allegation 1a, dishonest, in that Mr Ghani sought to confirm his supervisor did and could supervise his practical experience training in accordance with ACCA's requirements which he knew to be untrue.

- b) In respect of allegation 1b dishonest, in that Mr Ghani knew he had not achieved any or all the performance objectives referred to in paragraph 1b above he claimed as described in corresponding performance objective statements or at all.
4. By reason of his conduct, Mr Ghani is guilty of misconduct pursuant to ACCA bye-law 8(a)(i) in respect of any or all the matters set out at 1 to 2 above.

The Disciplinary Committee ordered that Mr Ghani be excluded and to pay costs to ACCA in the sum of £8,602.00

Please note that this may be the subject of an appeal.

ACCA's regulations require ACCA to publish the Committee's findings and orders by way of a news release, as soon as practicable.

** An order made by the Disciplinary Committee shall take effect from the date of expiry of the Appeal Period referred to in the Appeal Regulations unless the Committee directs that the order should have immediate effect*
