Disciplinary Committee ordered Student to be removed from the Student Register*

On 29 March 2022, the Disciplinary Committee of ACCA (the Association of Chartered Certified Accountants) found proved the following allegations against Mr Muntazir Mehdi from Lahore, Pakistan.

Allegations

Mr Muntazir Mehdi (Mr Mehdi), an Association of Chartered Certified Accountants ('ACCA') student:

- 1) Contrary to Regulation 3(1) of the Complaints and Disciplinary Regulations 2014 (as amended), Mr Mehdi failed to co-operate with the investigation of a complaint, in that whilst he responded to one email sent by ACCA on 16 June 2021, he has not responded or provided a sufficient response to any or all of the other correspondence sent by ACCA dated:
 - 13 April 2021; a.
 - b. 11 May 2021;
 - 26 May 2021; c.
 - 16 June 2021; d.
 - e. 12 July 2021;
 - f. 27 July 2021;
- 2) By reason of his conduct Mr Mehdi is:
 - Guilty of misconduct pursuant to bye-law 8(a)(i); in respect of any or all of the matters set out a. at allegation 1 above.
