Disciplinary Committee ordered student removed*

On 27 April 2023, the Disciplinary Committee of ACCA (the Association of Chartered Certified Accountants) found proved the following allegations against Mr Muhammadd Faizan Fayyaz of Ajman, United Arab Emirates:

Allegations

Mr Muhammadd Faizan Fayyaz (Mr Fayyaz), an Association of Chartered Certified Accountants ('ACCA') student:

- 1. Contrary to Regulation 3(1) of the Complaints and Disciplinary Regulations 2014 (as amended and as applicable in 2021), Mr Fayyaz failed to co-operate with the investigation of a complaint, in that he did not respond to any or all of ACCA's correspondence dated:
 - a. 20 May 2021;
 - b. 11 June 2021;
 - c. 28 June 2021
- 2. By reason of the conduct referred to above, Mr Fayyaz is:
 - a. guilty of misconduct pursuant to bye-law 8(a)(i);



The Disciplinary Committee ordered that Mr Fayyaz be removed from student membership and to pay costs to ACCA in the sum of £5,000.

Please note that this may be the subject of an appeal.

ACCA's regulations require ACCA to publish the Committee's findings and orders by way of a news release, as soon as practicable.

* An order made by the Disciplinary Committee shall take effect from the date of expiry of the Appeal Period referred to in the Appeal Regulations unless the Committee directs that the order should have immediate effect - ends –
