Disciplinary Committee ordered student removed*

On 04 August 2023, the Disciplinary Committee of ACCA (the Association of Chartered Certified Accountants) found proved the following allegations against Mr Safi Ullah of Peshawar, Pakistan:

Allegations

Mr Safi Ullah, a student member of ACCA, on 22 January 2021, during a remotely invigilated MA2 Managing Costs and Finance examination (the exam):

1. Engaged in improper conduct designed to assist him in the exam attempt in that he caused or permitted a third party to provide assistance during all or part of the exam, contrary to Examination Regulation 10.
2. Mr Ullah's conduct as referred to in allegation 1 above:
 - a. Was dishonest, in that Mr Ullah sought to obtain an unfair advantage in the exam by obtaining assistance from a third party.
3. By reason of his conduct, Mr Ullah is:
 - a. Guilty of misconduct pursuant to byelaw 8(a)(i), in respect of any or all of the matters set out at allegations 1 and/or 2 above.

The Disciplinary Committee ordered that Mr Ullah be removed from the student register and to pay costs to ACCA in the sum of £250.00
