Disciplinary Committee ordered student to be removed*

On 07 March 2023, the Disciplinary Committee of ACCA (the Association of Chartered Certified Accountants) found proved the following allegations against Mr Nadir Khan from Mardan, Pakistan:

Allegations

Mr Nadir Khan, a student member of the Association of Chartered Certified Accountants ('ACCA'):

1. On 21 November 2020, failed to comply with instructions issued by ACCA personnel (as per the Student Information Sheet) before a remotely invigilated FA2 Maintaining Financial Records exam, in that he failed to ensure he was in a room with no-one else around him, contrary to Examination Regulation 2.
2. Contrary to Regulation 3(1) of the Complaints and Disciplinary Regulations 2014 (as amended), Mr Khan failed to co-operate with the investigation of a complaint, in that he did not respond to any or all of ACCA's correspondence sent on:
 - (a) 14 April 2021;
 - (b) 18 May 2021; and
 - (c) 25 May 2021.

3. By reason of his conduct, Mr Khan is:

- (a) Guilty of misconduct pursuant to bye-law 8(a)(i), in respect of any or all of the matters set out at allegations 1 and/or 2 above.

The Disciplinary Committee ordered that Mr Khan be removed and to pay costs to ACCA in the sum of £5,500.00.

Please note that this may be the subject of an appeal.

ACCA's regulations require ACCA to publish the Committee's findings and orders by way of a news release, as soon as practicable.

** An order made by the Disciplinary Committee shall take effect from the date of expiry of the Appeal Period referred to in the Appeal Regulations unless the Committee directs that the order should have immediate effect*
