## Disciplinary Committee ordered student removed\*

On 23 March 2023, the Disciplinary Committee of ACCA (the Association of Chartered Certified Accountants) found proved the following allegations against Ms Amna Shah from Rawalpindi, Pakistan:

## Allegations

Miss Amna Shah ("Miss Shah"), a student of the Association of Chartered Certified Accountants ("ACCA"):

- 1. Contrary to Paragraph 3(1) of the Complaints and Disciplinary Regulations 2014 (as amended), failed to cooperate with the investigation of a complaint, in that she did not respond to any or all of ACCA's correspondence dated:
  - a) 11 May 2021;
  - b) 08 June 2021;
  - c) 01 July 2021.
- 2. On 04 January 2021, during and in relation to an FA1 Recording Financial Transactions examination (the 'Exam'):
  - a) Contrary to Examination Regulation 16, communicated or attempted to communicate with a person other than an exam supervisor, invigilator or proctor, during the course of the Exam;

3.	By reaso	on of her conduct in respect of any or all of the matters set out at Allegations 1 and/or 2, is:
	a)	Guilty of misconduct pursuant to bye-law 8(a)(i).
The Dis	ciplinary	Committee ordered that Ms Shah be removed and to pay costs to ACCA in the sum of £6,800.

ACCA's regulations require ACCA to publish the Committee's findings and orders by way of a news release, as soon

to in the Appeal Regulations unless the Committee directs that the order should have immediate effect

as practicable.
