Disciplinary Committee ordered student removed

On 15 November 2023, the Disciplinary Committee of ACCA (the Association of Chartered Certified Accountants) found proved the following allegations against Mr Muhammad Nouman Khan of Stockport, United Kingdom:


Allegations

1. On 07 March 2023, Mr Muhammad Nouman Khan, an ACCA student:
 - a) Used, or caused or permitted a third party to use, an unauthorised item, during ACCA's Strategic Business Leader ("SBL") remotely invigilated exam, to take photographs of one or more of the exam questions contrary to Exam Regulation 5a, and/or 12.
 - b) Caused or permitted the photographs referred to in Allegation 1a, to be shared with a person or persons unknown, contrary to Exam Regulation 10 and/or 14.

2. Mr Khan's conduct was:
 - a) In respect of allegation 1 a, dishonest in that the taking and retaining of the photographs of the exam questions could potentially assist him if he had to resit the same exam and thereby provide him with an unfair advantage and/or

b) In respect of allegation 1 b, dishonest in that sharing the photographs with another or other exam candidates sitting the same exam could provide them with an unfair advantage.

5. By reason of any or all of the facts at allegations , 1 – 3, Mr Khan is,

a) Guilty of misconduct pursuant to bye-law 8(a)(i)

The Disciplinary Committee ordered that Mr Khan be removed from ACCA student register and to pay costs to ACCA in the sum of £1500 00

Please note that this may be the subject of an appeal.

ACCA's regulations require ACCA to publish the Committee's findings and orders by way of a news release, as soon as practicable.

** An order made by the Disciplinary Committee shall take effect from the date of expiry of the Appeal Period referred to in the Appeal Regulations unless the Committee directs that the order should have immediate effect*
