Disciplinary Committee ordered member excluded

On 26 October 2023, the Disciplinary Committee of ACCA (the Association of Chartered Certified Accountants) found proved the following allegations against Miss Yuhao Xiang of Jiangyou, China:

Allegations

Yuhao Xiang ('Miss Xiang'), at all material times an ACCA trainee,

1. Applied for membership to ACCA on or about 26 October 2020 and in doing so purported to confirm in relation to her ACCA Practical Experience training record:
 - a) Her Practical Experience Supervisor in respect of her practical experience training in the period from 6 July 2017 to 25 October 2020 was Person 'A' when Person 'A' did not supervise that practical experience training in accordance with ACCA's requirements as published from time to time by ACCA or at all.
 - b) She had achieved the following Performance Objectives which was not true:
 - Performance Objective 1: Ethics and professionalism
 - Performance Objective 2: Stakeholder relationship management
 - Performance Objective 5: Leadership and management
 - Performance Objective 17: Tax planning and advice
 - Performance Objective 18: Prepare for and plan the audit and assurance process

- Performance Objective 20: Review and report on the findings of an audit or assurance engagement

2. Miss Xiang's conduct in respect of the matters described in Allegation 1 above was: -

- a) In respect of Allegation 1a), dishonest, in that Miss Xiang sought to confirm her Practical Experience Supervisor did supervise her practical experience training in accordance with ACCA's requirements or otherwise which she knew to be untrue.
- b) In respect of allegation 1b) dishonest, in that Miss Xiang knew she had not achieved the performance objectives referred to in paragraph 1b) above as described in the corresponding performance objective statements or at all.

4. Failed to co-operate with ACCA's Investigating Officer in breach of Complaints and Disciplinary Regulation 3(1) in that she failed to respond fully or at all to any or all of ACCA's correspondence dated:

- (a) 19 August 2022;
- (b) 05 September 2022;
- (c) 20 September 2022.

5. By reason of her conduct, Miss Xiang is

- a) Guilty of misconduct pursuant to ACCA bye-law 8(a)(i) in respect of any or all the matters set out at 1 to 4 above; in the alternative in respect of allegation 4 only.

The Disciplinary Committee ordered that Miss Yuhao Xiang be excluded from membership and to pay costs to ACCA in the sum of £5200 00

Please note that this may be the subject of an appeal.

ACCA's regulations require ACCA to publish the Committee's findings and orders by way of a news release, as soon as practicable.

** An order made by the Disciplinary Committee shall take effect from the date of expiry of the Appeal Period referred to in the Appeal Regulations unless the Committee directs that the order should have immediate effect*
