## Disciplinary Committee ordered affiliate severely reprimanded\*

On 26 March 2024, the Disciplinary Committee of ACCA (the Association of Chartered Certified Accountants) found proved the following allegations against Miss Hongxuan Xiang of Salford, United Kingdom:

## Allegations

Miss Xiang who is an ACCA (Association of Chartered Certified Accountant) affiliate:

- 1. On or around 19 December 2021, used a questions and suggested answers document to assist her in the PricewaterhouseCoopers (PwC) internal training Assessment Remote Access Day 2 assessment.
- 2. Miss Xiang's conduct in respect of Allegation 1 was:
  - ii. Failure to demonstrate integrity.
- 3. By reason of her conduct Miss Xiang is:
  - i. Guilty of Misconduct pursuant to bye-law 8(a)(i) in respect of all the matters set out above.

The Disciplinary Committee ordered that Miss Xiang be severely reprimanded and to pay costs to ACCA in the sum of £1,600.

Please note that this may be the subject of an appeal.
