## Notice of hearing

A hearing of ACCA's Disciplinary Committee will take place at 08:00am on 12 June 2025. It will be held remotely but based at the ACCA's Offices, The Adelphi, 1-11 John Adam Street, London, WC2N 6AU.

The hearing is open to any member of the public or the media who wish to attend. However, ACCA is only able to accommodate remote access to the hearing. Please contact adminadjudication@accaglobal.com to obtain information about attending this (or any other) hearing.

The case to be heard on this day concerns Ms Xinxin Xia.

## **Allegations**

Ms Xinxin XIA ('Ms Xia'), at all material times an ACCA trainee:

- 1) On or about 22 January 2022 in relation to her ACCA Practical Experience Training Record caused or permitted a third party.
  - a) to register Person A as her practical experience supervisor and further,
  - b) to approve in Person A's name 88 months of qualifying experience and further,
  - c) to approve in Person A's name her nine performance objectives.
- 2) Whether by herself or through a third party applied for membership to ACCA on or about 17 January 2024 and in doing so purported to confirm in relation to her ACCA Practical Experience Training Record she had achieved all or any of the following.

## Performance Objectives:

- Performance Objective 1: Ethics and professionalism
- Performance Objective 2: Stakeholder relationship management
- Performance Objective 3: Strategy and innovation
- Performance Objective 4: Governance, risk and control
- Performance Objective 5: Leadership and management
- Performance Objective 7: Prepare external financial reports
- Performance Objective 8: Analyse and interpret financial reports
- Performance Objective 14: Monitor performance
- Performance Objective 18: Prepare for and plan the audit and assurance process
- 3) Ms Xia's conduct in respect of the matters described above was:
  - a) In relation to Allegation 1 a), dishonest in that Ms Xia knew her supervisor, Person A, had been falsely registered as her practical experience supervisor.
  - b) In relation to Allegation 1 b), dishonest in that Ms Xia knew her supervisor, Person A, had not approved her qualifying experience.
  - c) In relation to Allegation 1 c), dishonest in that Ms Xia knew Person A had not approved her nine performance objectives.
  - d) In relation to Allegation 2, dishonest in that Ms Xia knew she had not achieved all or any of the performance objectives as described in the corresponding performance objective statements or at all.

e) In the alternative, any or all of the conduct referred to in Allegations 1 and 2 above demonstra	ates a
failure to act with Integrity.	

- 4) In the further alternative any or all of the conduct referred to in Allegations 1 and 2above was reckless in that:
  - a) Ms Xia failed to ensure that her Practical Experience training Record was approved in all material respects by her practical experience supervisor.
  - b) Ms Xia paid no or insufficient regard to ACCA's requirements to ensure that the statements corresponding with the performance objectives referred to in Allegation 2 accurately set out how each objective had been met.
- 5) By reason of her conduct, Ms Xia is guilty of misconduct pursuant to ACCA bye-law 8(a)(i) in respect of any or all the matters set out at 1 to 4 above.

The allegations listed above are current at the date of publication.

The case will be heard by a panel of the ACCA's Disciplinary Committee.
