Notice of hearing

A hearing of ACCA's Disciplinary Committee will take place at 09:30am on 25 June 2025. It will be held remotely but based at the ACCA's Offices, The Adelphi, 1-11 John Adam Street, London, WC2N 6AU.

The hearing is open to any member of the public or the media who wish to attend. However, ACCA is only able to accommodate remote access to the hearing. Please contact adminadjudication@accaglobal.com to obtain information about attending this (or any other) hearing.

The case to be heard on this day concerns Mr John Taremeredzwa.

<u>Allegations</u>

Mr John Taremeredzwa, a registered student of the Association of Chartered Certified Accountants ("ACCA"):

- On 19 March 2024, Mr Taremeredzwa submitted or caused to be submitted an ACCA Professional 1) Level Certificate dated December 2015 ("Certificate") purportedly from ACCA to Person A ("Person A") which was false.
- 2) Mr Taremeredzwa's conduct at allegation 1) above, was:
 - Dishonest, in that he knew the document he submitted or caused to be submitted to Person A a) was false; or in the alternative:
 - b) Such conduct demonstrates a lack of integrity.
- 3) Contrary to Regulation 3 (1) of the Complaints and Disciplinary Regulations 2014 (as amended in 2024), Mr Taremeredzwa, failed to co-operate with the investigation of a complaint in that he failed to respond to any or all of ACCA's correspondences dated:

a) ZU MUUUSI ZUZ4	a)	20 August	2024

- b) 05 September 2024
- c) 24 September 2024
- 4) By reason of the conduct described in any or all of the matters set out at allegation 1, 2, and 3, Mr Taremeredzwa is:
 - a) Guilty of misconduct pursuant to bye-law 8(a)(i); or in the alternative:
 - b) Liable to disciplinary action, pursuant to bye-law 8(a)(iii).

The allegations listed above are current at the date of publication.

The case will be heard by a panel of the ACCA's Disciplinary Committee.
