## **Disciplinary Committee ordered member excluded\***

On 30 June 2025, the Disciplinary Committee of ACCA (the Association of Chartered Certified Accountants) found proved the following allegations against Miss Qi Jie Wang of Shanghai, China:

### Allegations

Qi Jie Wang ('Miss Wang'), at all material times an ACCA trainee:

- 1) Applied for membership to ACCA on or about 05 September 2021 and in doing so purported to confirm in relation to her ACCA Practical Experience Training Record she had achieved all or any of the following Performance Objectives:
  - Performance Objective 5: Leadership and management •
  - Performance Objective 6: Record and process transactions and events •
  - Performance Objective 7: Prepare external financial reports •
  - Performance Objective 9: Evaluate investment and financing decisions •
  - Performance Objective 13: Plan and control performance
- 2) Miss Wang's conduct in respect of any or all of the matters described in Allegation 1 demonstrates a failure to act with integrity given that the corresponding statements to the performance objectives were not written in her own words as required by ACCA.
- 4) Failed to co-operate with ACCA's Investigating Officer in breach of Complaints and Disciplinary Regulation 3(1) in that she failed to respond fully or at all to any or all of ACCA's correspondence dated,
  - a) 16 October 2023
  - b) 31 October 2023
  - c) 15 November 2023

5) By reason of her conduct, Miss Wang is:

- a) Guilty of misconduct pursuant to ACCA bye-law 8(a)(i) in respect of any or all the matters set out at 1 to 4 above.

The Disciplinary Committee ordered that Miss Qi Jie Wang be excluded from membership with immediate effect and to pay costs to ACCA in the sum of £5655.00.

Please note that this may be the subject of an appeal.

ACCA's regulations require ACCA to publish the Committee's findings and orders by way of a news release, as soon as practicable.

*\* An order made by the Disciplinary Committee shall take effect from the date of expiry of the Appeal Period referred to in the Appeal Regulations unless the Committee directs that the order should have immediate effect*
