Disciplinary Committee ordered Severe Reprimand*

On 28 May 2025, 06 August 2025 and 02 october 2025, the Disciplinary Committee of ACCA (the Association of Chartered Certified Accountants) found proved the following allegations against Miss Yanjie Mu of Hangzhou, China:

<u>Allegations</u>

Yanjie Mu ('Miss Mu'), at all material times an ACCA trainee:

- On or about 05 February 2023 in relation to her ACCA Practical Experience Training Record caused 1) or permitted a third party
 - To register Person A as her practical experience supervisor and further, a)
 - To approve in Person A's name 59 months of qualifying experience and further, b)
 - c) To approve in Person A's name her nine performance objectives.
- 2) Applied for membership to ACCA on or about 05 February 2023 and in doing so purported to confirm in relation to her ACCA Practical Experience training record she had achieved the following Performance Objectives:
 - Performance Objective 1: Ethics and professionalism
 - Performance Objective 2: Stakeholder relationship management
 - Performance Objective 3: Strategy and innovation
 - Performance Objective 4: Governance, risk and control
 - Performance Objective 5: Leadership and management
 - Performance Objective 6: Record and process transactions and events
 - Performance Objective 7: Prepare external financial reports
 - Performance Objective 9: Evaluate investment and financing decisions
 - Performance Objective 13: Plan and control performance

- 3) Miss Mu's conduct in respect of the matters described above was:
 - e) Any or all of the conduct referred to in Allegations 1 and 2 above demonstrates a failure to act with Integrity.
- 5) By reason of her conduct, Miss Mu is guilty of misconduct pursuant to ACCA byelaw 8(a)(i) in respect of all the matters set out at 1 to 3 above.

The Disciplinary Committee ordered that Miss Yanjie Mu be severely reprimanded and to pay costs to ACCA in the sum of £500.00.

Please note that this may be the subject of an appeal.

ACCA's regulations require ACCA to publish the Committee's findings and orders by way of a news release, as soon as practicable.

* An order made by the Disciplinary Committee shall take effect from the date of expiry of the Appeal Period referred to in the Appeal Regulations unless the Committee directs that the order should have immediate effect
