Notice of hearing

A hearing of ACCA's Disciplinary Committee will take place at 08:00am on 09 June 2026. It will be held remotely but based at the ACCA's Offices, The Adelphi, 1-11 John Adam Street, London, WC2N 6AU.

The hearing is open to any member of the public or the media who wish to attend. However, ACCA is only able to accommodate remote access to the hearing. Please contact adminadjudication@accaglobal.com to obtain information about attending this (or any other) hearing.

The case to be heard on this day concerns Miss Leer Hu.

Allegations

Miss Leer Hu, an ACCA student, during a centre-based Performance Management (PM) examination on 04 June 2025 ('the Exam'):

1. Possessed and/or used an unauthorised item, namely a mobile phone with camera ("the unauthorised item"), contrary to Examination Regulation 5(a) and/or 5(b).
2. Took photographs of Exam content, presented to her ("the photographs"), contrary to Exam Regulation 13.
3. Shared the photographs with a third party or parties unknown, contrary to Exam Regulation 13.
4. Possessed and/or used written materials, in electronic form on the unauthorised item ("the unauthorised materials"), contrary to Exam Regulation 4.
5. Miss Leer Hu's conduct set out in Allegation 1, 2, 3 and/or 4 above was:

Dishonest in that she gained or intended to gain an unfair advantage in the;

- a) Exam and/or a future exam, via the conduct or
 - b) In alternative, such conduct demonstrates a failure to act with integrity.
6. Miss Leer Hu failed to co-operate with the consideration or investigation of this complaint, in that she failed to respond to any or all of ACCA's correspondences, contrary to Regulation 3(1) of the Complaints and Disciplinary Regulations 2014 (as amended), on the following dates:
- (a) 19 August 2025;
 - (b) 09 September 2025;
 - (c) 07 October 2025;
 - (d) 20 October 2025.
7. By reason of any or all of her conduct set out in Allegation 1 to 6 above, Miss Leer Hu is:
- a) Guilty of misconduct pursuant to bye-law 8(a)(i) or
 - b) In the alternative, liable to disciplinary action pursuant to bye-law 8(a)(iii) in respect of Allegation 1, 2, 3, 4 and/or 6.

The allegations listed above are current at the date of publication.

The case will be heard by a panel of the ACCA's Disciplinary Committee.
