# Ukrainian nationals with family in the UK

# Ukraine Family Scheme visa

Enables you to enter the UK if your family members are a British national, UK settled or certain others. You will be able to live, study and work in the UK, with access to public funds.

This free scheme will grant you leave for three years.

# Eligibility

- must be applying to join or accompany a UK family member
- must be Ukrainian or the immediate family member of a Ukrainian national who is applying to the scheme
- must have been a resident in Ukraine before 1 January 2022.

# Ukrainian nationals with no family in the UK

#### Homes for Ukraine

If you have a named sponsor under the <u>Homes for Ukraine</u> scheme, Ukrainian nationals and family members can come to the UK. This allows you to stay in the UK for up to three years. *Eligibility*:

- must be Ukrainian or be an immediate family member of a Ukrainian national
- must have been residing in Ukraine before 1 January 2022
- must be currently outside the UK
- must have a UK-based sponsor eligible for the Homes for Ukraine scheme.

# 'Immediate family member' includes:

- spouse/civil partner
- unmarried partner (living together for at least two years)
- children under 18
- parent if you are under 18
- fiancé(e) or proposed civil partner

#### Visa application centres

You need to apply for a visa at the nearest visa application centre (VAC) and upload relevant documents online before attending the appointment. Includes fees.

VACs in Ukraine are closed but you may apply in any country if you can travel safely. For those applying to the Ukraine Family Scheme, there is a temporary VAC in Rzeszow, Poland: find our more at https://pos.tlscontact.com/rze\_en/address.

#### Other VAC locations include:

- Budapest, Hungary
- Chisinau, Moldova
- Warsaw, Poland
- Bucharest, Romania
- Paris, France

You need to make an appointment, complete the online application form and have a global web form (GWF) reference number.

# Working in the UK

The Homes for Ukraine scheme allows you to live and work in the UK for up to three years. You will have access to benefits, healthcare, employment support, education and other support.

Ukrainian nationals may also get visas to work in the UK through the points-based immigration system. These are:

# **Travelling with pets**

Rules for Great Britain (England, Wales and Scotland)

You can enter or return to the UK with dogs, cats and ferrets only if they:

- are microchipped
- have a pet passport/health certificate
- are vaccinated against rabies
- have taken any required blood tests.

Dogs are expected to have a tapeworm treatment.

Failure to follow the rules may result in pets being put into quarantine for up to four months or refused if you travelled by sea.

If you bring a banned breed of dog into Great Britain, it can be taken away by the police or local authorities and may be destroyed.

# **Obtaining a British passport**

HM Passport Office is currently unable to accept new applications for British passports from Ukraine.

#### Travelling to Ireland from Ukraine

You do not need a visa or proof that you have a Covid-19 vaccine to travel to Ireland. No Covid-19 tests are required.

Any form of identification is accepted for travel if you do not have a current passport. These include a national ID card, expired passport or birth certificate.

If travelling with non-Ukrainian family members, you will need a visa to come to Ireland. Check the visa requirements at www.citizensinformation.ie/en/moving\_country.

# Ukraine support centres

Help and information can be found at centres in Cork, Limerick and Dublin. More centres will be added.

- **Dublin** (map): Intreo Centre, Guild Building, Cork Street, Dublin D08 XH90
- Cork (<u>map</u>): Cork City PSC and PPSN Centre, Department of Social Protection, Hanover Street, Cork T12 PX62
- Limerick (<u>map</u>): 2nd floor, Riverstone House, 23-27 Henry Street, Limerick City V94 R7YE

The centres provide information about social welfare, immigration and housing. Temporary permission letters are available from the Dublin centre.

Ukrainian refugees are entitled to use <u>public healthcare services</u>. They can also receive housing support at reception centres at Dublin Airport and Rosslare Europort.

# Right to work in Ireland

Ukrainians have the right to work in Ireland if they have proof that they have been granted a temporary residence permit under the EU's Temporary Protection Directive. This includes self-employment and vocational training.

#### Keep up to date

The rules and regulations change according to the circumstances; to receive updates, it is advisable to either create a GOV.UK account (which requires a UK mobile phone number) or subscribe to receive alerts.
