

Recognition as High-end Talents by China Government Authorities

ACCA members are being recognised as **High-end Financial Talents** by various government bodies all over China. Due to the exceptional competitiveness and professionalism demonstrated, ACCA members have been recognised by many government agencies including Beijing, Shanghai, Tianjin, Nanjing, Ningbo, Chengdu, Chongqing, Wuhan, Guangzhou, Zhuhai, Huizhou, Shenzhen, Qingdao, Nanchang, Dalian, Xi'an, Shenyang, Nanning, Jiangsu, Zhejiang, Anhui, Henan, Sichuan, Hubei, Hainan, Yunnan, Gansu, Fujian and Zhanjiang.

The ACCA Qualification is so well regarded that it is used as criteria to assess whether employees have the professional competence to be promoted to senior management in some provinces. Incentive measures have been introduced to attract ACCA members to be employed locally, which includes benefits such as bonus, awards, subsidies, housing, health care, children education and family care etc. Having the ACCA designation opens doors to limitless career opportunities and advancement paths, and better employability globally.





The 2nd ACCA GBA CFO Summit

As the first professional body entering the GBA, ACCA not only cultivates high-end talents for the region but also contributes to build a stronger Bay Area with professional insights and networks through gathering together government representatives, experts and scholars, outstanding entrepreneurs and finance leaders.

The **2nd ACCA GBA CFO Summit** was held simultaneously in Hong Kong and Shenzhen on 25 November 2022 – featuring innovations, capital opportunities and supply chain challenges in the region. The event was kicked off by Ada Leung, Director of ACCA China; Joseph Chan JP, Under Secretary for Financial Services and the Treasury of the Hong Kong Special Administrative Region; and Wang Jinxia, Deputy Director of Shenzhen Qianhai Administration.

It was our first-ever hybrid event taking place simultaneously in both venues. Going digital maximised our reach to over 10,000 participants, while we're able to maintain the value of in-person interactions for 200 key stakeholders in the two cities, fostering critical relationship building.

ACCA Enterprise Excellence Award for Training Innovation was presented to Chow Tai Fook Jewellery Group from Hong Kong, and China General Nuclear Power Corporation Limited (CGN) from China. The award is a recognition of their organisations' support for ACCA members and their finance team during the age of digital transformation and sustainability through integrating ACCA related content into their internal training programmes.

Professional Luncheon on Global Talent Trends



On 29 March 2023, ACCA Hong Kong Professional Luncheon was successfully held and well-attended by over 60 young members, top achievers, CFO members and employer partners. Key findings from ACCA's Global Talent Trends 2023 report were shared, on the unique characteristics of talent opportunities and challenges, and with a special focus on the emerging talent trends in Hong Kong. As the war for global talent acquisition has become more intense, we also discussed the government initiatives of talent trawl in the wider Asia Pacific region such as Singapore and Taiwan, as well as ACCA's recognition in China reflected by the Talent Reward Scheme in different cities. ACCA Virtual Careers Fair

ACCA's global network supports our members' employability over the globe. A series of **Virtual Careers Fair** (VCF) was held over 2022-23 including China VCF in August, EU VCF in October, UK VCF in November and APAC VCF for BFSI (banking, financial services and insurance) sector in December. The VCF series enabled visitors to have live chat with their potential future employers. Comprehensive content was presented in the auditorium including a live forum with employer sections throughout the event day. Visitors were also able to find useful resources about careers development in the profession at the resources centre



Continuous upskilling to boost employability

Sustainability becomes one of the most relevant training topics for corporates according to ACCA Global Employer Survey. ACCA has launched two ESG related certification programmes – ACCA-CFA Institute Climate Finance course and Certification in Sustainability for Finance for members and employers to upskill themselves and get prepared for those policy changes on ESG reporting.

Our Climate Finance course, developed in collaboration with CFA Institute, is now one of the Eligible Programmes under the HKSAR Government's Pilot Green and Sustainable Finance Capacity Building Support Scheme, effective 6 June 2023. Upon successful completion of the programme, eligible applicants may claim up to 80% of the reimbursable fees (full-time students may enjoy up to 100% reimbursement).

Free Tax Advisory Services

Since 1999, ACCA Hong Kong has organised its **Free Tax Advisory Services** during which its members provide voluntary assistance to the public in completing their Tax Return – Individuals. The event has continued to receive the support from the Inland Revenue Department (IRD) whose officials would provide a briefing on the latest development and changes to the income tax return form to ACCA volunteers prior to the event every year. Hotline services for six days were offered to the public during the tax filing period in late June 2022. Over ten of thousands of the public have benefited from this service throughout the years.



HKSAR Budget 2023/24

This was the first Budget since the pandemic subsided – an important time to set the direction ahead and specific goals for the rebound. 


Leading Diversity in Accountancy Webinar


