EXEMPTIONS

If you have passed the ATI qualification, you will get exemptions from the three papers under Applied Knowledge as well as the Corporate and Business Law paper of the Applied Skills level, leaving you with 9 exams to complete upon claiming your exemptions.

EXAMS

Exams are divided into two levels: Applied Skills and Strategic Professional. For more information on each exam and the various options available, see the table opposite.

ETHICS

Each of our ACCA students takes the takes the Ethics and Professional Skills Module. Ethics underpins your key decision-making, and although the ACCA Qualification will provide you with all the key technical knowledge you need, we also want to ensure ethics is ingrained in your day-to-day business decisions.

EXPERIENCE

To become a professional accountant, you need three years of relevant work experience and to fulfil key performance objectives. This enables you to become a fully developed finance professional, gain experience in lots of different areas and get the job you deserve. Details of performance objectives are on the page opposite.

DESCRIBE YOUR CAREER JOURNEY AND HOW YOU CAME TO STUDY ATI AND THEN ACCA?

For many years I focussed my efforts on raising my children, as a full-time mum of four. Once all my children reached a certain stage, I starting find myself with more time, I began to consider what my future may hold, whether I might embark in a new direction. My searching eventually led me to the ATI course, which greatly interested me and stood out among other options as one which suit my personal and professional desires. ATI allowed me to develop my new interest and aided me in establishing a solid foundation in accounting and tax. I went on to avail of the opportunity to join the 3rd year of an accounting and finance honours degree, graduated with a 1st class honours degree and achieved the highest GPA overall. My degree gave me 9 exemptions from the then 14 ACCA exams; it was the logical course for me to continue on with the ACCA qualification.

WITH ALL THE DIFFERENT FINANCE QUALIFICATIONS OUT THERE TO CHOOSE FROM, WHY DID YOU PICK ACCA?

ACCA allows for greater flexibility. The exams can be taken one at a time rather than as a block of exams taken in one go. There are four sittings throughout the year, which is very practical and allows one to tailor the exams around other commitments. My degree also enabled me to earn nine exemptions so that I only needed to complete a further 5 professional level papers.

In addition, as my passion actually lay in tax, I desired to register with the Institute of Tax to study for the CTA exams as soon as possible.

TELL US A BIT MORE ABOUT YOUR CURRENT ROLE?

I am a member of the MetLife tax team currently made up of 10 people based in the Dublin office. The team support all countries that operate within EMEA from a tax perspective. It is a broad and varied tax role within one of the largest insurance multinational companies in the world.

Duties & responsibilities include:

- Assisting in the preparation of the Irish/UK Tax compliance process
- Supporting the MEA Regional Tax Manager with the local country tax requirements
- Lead the co-ordination of the Annual CFC Tax return process for all of EMEA
- Assist in the preparation of monthly/quarterly tax provisioning & reporting processes under U.S. GAAP and Solvency II

HOW HAS THE ACCA QUALIFICAION BENEFITTED YOUR CAREER?

Having both ACCA and the CTA qualification has opened a whole new career for me. There are countless opportunities available to me. Literally the world is my oyster!

WHAT DO YOU ENJOY MOST ABOUT YOUR JOB?

The role enables me to employ my knowledge of both accounting and tax, and offers me exposure to UK and Irish Tax Compliance, as well as USGAAP and Solvency II tax and accounting principles.

I am working with a high-performance team, with an abundance of experience and knowledge. There is also a great work life balance, as the working hours tend to be very consistent.

WHAT'S YOUR NEXT BIG CAREER GOAL?

I have recently undertaken lecturing in Tax and plan to continue this on a permanent basis.

WHAT ADVICE WOULD YOU GIVE TO ATI STUDENTS THINKING ABOUT PROGRESSING TO ACCA?

ACCA is the natural progression for ATI students. ATI is the perfect spring board to launch a professional career in accounting. It covers all the core subjects and will give a great grounding for the ACCA papers.

There really is little to consider, as it makes perfect sense to progress to ACCA from ATI.

FAQs and fees

WHY SHOULD I CHOOSE ACCA AND NOT ANOTHER ACCOUNTANCY BODY?

I'M NOT SURE WHAT AREA I WANT TO SPECIALISE IN YET, DOES THAT MATTER?

Not at all, as you progress through your work experience and studies, you can choose option papers to suit your interests.

With the ACCA Qualification, you can work in any area – from audit to management accounting. Don't limit yourself too early!

HOW LONG WILL IT TAKE TO QUALIFY WITH ACCA?

We require that all of our members qualify with three years of relevant work experience, so depending on how much experience you've accrued prior to starting your ACCA studies, the qualification can take anything from 2-5+ years to complete.

HOW DO I REGISTER AS AN ACCA STUDENT?

Registration is easy – you can do it at any time of the year and it shouldn't take more than 15 minutes to submit the correct

documents and provide us with everything we need. Make sure you have the following ready:

- Proof of your qualifications (ATI certificate of completion and course transcripts)
- Proof of ID (birth certificate, passport or driving licence)
- Passport-style photo.

*If you're still studying or awaiting documents, then provide details of any completed qualifications – you can then add transcripts at a later date.

Please note, to make it easier – we accept pictures of your documents taken on a phone if you haven't got them in PDF.

HOW DO I ENTER FOR EXAMS?

To enter for exams, you must first register as a student with ACCA and pay your annual subscription fee. After you've done this, the best way to enter for exams is to login to your *myACCA* account where you can select your required papers.

INITIAL FEES*

When you register, you need to pay the following fees to complete your application:

Initial registration £79 (one off) Annual subscription £105 (yearly)

Annual subscription enables you to stay on our register as an ACCA student. You will also be able to enter for exams and fully benefit from wealth of resources available on our website.

EXAM FEES

Depending on when you register, our exam fees range from £114 – £307. Registering early can mean significant savings.

We have exam sittings in March, June, September and December. Early entry starts roughly four months before each sitting.
