Partnerships

We are currently working on formalising a relationship with HFMA so that we are able to have a presence at member and student events across the country and promote our ACCA Learning and Advantage initiatives.

Thanks to Sinead and Maddy, we are also developing a partnership with the BioIndustry Association (BIA).

Discussion and insight from panel members

The following issues were raised:

- LinkedIn usage is generally lower in the public sector as it is still seen primarily as a jobhunting site – need to consider other ways of reaching out to members
- exemption costs are proving to be a hindrance when choosing ACCA, a review of this situation is underway
- ACCA's Advantage programme is there to support organisations looking to recruit interns and placements
- more support is needed around promoting critical thinking in the NHS, with case studies to support it
- funding continues to be an issue for the pharmaceutical sector, in particular for start-ups and around venture capital
- lack of funding also affects the development and rollout of clinical trials in the NHS
- face-to-face meetings should be encouraged for members in the different regions the <u>LinkUp</u> programme can help with this
- the development of a WhatsApp group for the panel, to keep in touch between meetings, with Connie taking the lead
- informal catch up between meetings via virtual "coffee mornings"
- the opportunity to get involved in ACCA's policy work via the policy insights group
- the opportunity to share ACCA updates in NHS newsletters
- working with universities to recruit future talent into the NHS
- the proliferation of "efficiency schemes" and the need for case studies and examples of successful ones
- the overwhelming amount of training and development provided by different sources within the NHS and the need to be able to focus on specific resources
