### **Partnerships**

Key partnerships have been built with <u>LG Improve</u>, <u>British Universities Finance Directors Group</u> (BUFDG) and the <u>Charity Finance Group</u> (CFG) We are also in discussion with the National Housing Federation to develop a more formal partnership. In discussions with BUFDG the issue of whether universities belong in the public sector was raised and will be for future discussion – Anna raised the fact that the ONS are doing some work in this area which should be complete by the end of the year. I will be attending the CFG technical update to gain knowledge and potential speakers for our work supporting members in the sector.

### Panel name change

Based on feedback from members, and to reflect the large percentage of not-for-profit members in the public sector in the UK, the panel will now be known as the "Public and Not-for-Profit Sector Community Panel". The UK LinkedIn group's name has also been updated.

#### Website update

A dedicated public sector hub is being developed and will be the one-stop-shop for everything related to the public sector.

### **Discussion and Insight from Panel members**

Key points discussed in the meeting:

- sending a survey of current trends to members via Microsoft Forms
- holding one face-to-face panel meeting a year, with informal "coffee catch ups" in between
- getting more involved in ACCA's policy work, which includes attending party conferences, working with MPs and ministers and leading strategic engagement in England, Scotland and Wales, initially via the member insights group (security settings allowing)
- the importance of involving school leavers and young people in promoting the attractiveness of the profession
- a suggested discussion around whether universities sit within the public sector, depending on their funding. BUFDG are interested in being part of the debate.
- keeping in touch via WhatsApp Angela agreed to add those who were willing to share their numbers
- more support and training for finance business partners in the sector is needed (this will be touched on in the "Talking Public Sector" discussion on 21/9/23
- the need to showcase ACCA's public sector offering better
- recruitment issues caused by lower wage offerings and long recruitment lead times
- crumbling concrete is likely to be more widespread across sector buildings
- social mobility and the leveling up agenda
